Dear Candidate:

The Politicians and News Media want you to believe that people hate us for what we have. This is not true. They hate our Government because it protects the Israeli Government from being prosecuted for its crimes against the Palestine Gentiles and its illegal invasion and occupation of its neighbor's lands.

The latest example was when 344 members of the US House of Representatives (Democrats, Independent Democrats, and Republicans), without doing a study of their own, voted against the Goldstone report which found that Israel committed War Crimes during its attack on the Palestine Gentiles at the end of 2008.

The President of the Human Rights Council appointed Justice Richard Goldstone, former judge of the Constitutional Court of South Africa and former Prosecutor of the International Criminal Tribunals for the former Yugoslavia and Rwanda, to head the Mission. Goldstone, both a Jew and a Zionist, condemned Israel's policy of collective punishment of a people under effective occupation, destroying their means to live a dignified life as well as the trauma caused by the kind of military intervention the Israeli government used in its Operation Cast Lead.

In the past the United States has prevented the prosecution of Israel for Genocide and Massacres of the Palestine Gentiles. How does the United States do this? The United States is one of the Nations that have veto power over any action taken by the United Nations and this veto power is used to prevent the prosecution of Israel for its crimes.

Our politicians like to pronounce that we are a Nation of Laws, but this is a meaningless statement since the laws are not enforced equally on all people. They need to proclaim that "We are a Nation of laws enforced equally on all people".

Why does Congress protect Israel from prosecution for its crimes? The likely reason is that Congress approves of our taxpayer money and taxpayer provided weapons that Israel uses to commit these crimes, which makes them culpable for the crimes committed by Israel.

Why does Congress believe that the brutal treatment of Palestine Gentiles is not a War Crime? It's likely that the American Israeli Public Affairs Committee (AIPAC) told them how to vote. AIPAC not only tells members of Congress how to vote, they also draft legislation acceptable to Israel, and candidates and appointees for office are vetted to insure they are pro-Israel. If they are pro-Israel, they get support, if not; every effort will be made to defeat them unless they are likely to lose anyway.

Let's say that the Catholics have an American Vatican Public Affairs Committee (AVPAC) which writes legislation acceptable to the Vatican, selects candidates acceptable to the Vatican, and tells member of Congress how to vote. It would be like AIPAC except that it would claim to support the Vatican and Catholics/Christians instead of Israel and Jews/Judaism. Would this be a violation of the United States Constitution? Would this be an Un-American activity?

Other alleged crimes which the United States has prevented Israel from being prosecuted for are Genocides and Massacres against the Palestine Gentiles, illegal invasions and occupations of neighboring States, the building of illegal settlements on Palestine Gentile land and the bulldozing down of Palestine Gentile homes. Israel has made over 50 attacks on the Palestine Gentiles. In one instant Rachel Corrie, an American, was run over and killed by a bulldozer while trying to protect the home of a Palestine Gentile. Her parents in an attempt to get some redress filed a lawsuit in the 9th Circuit Court. The Judge threw out the case. He said it was a political matter because the United States Government bought the bulldozer from Caterpillar and gave it to Israel.

Why doesn't our News Media report over and over on these crimes against the Gentiles? Is it because of who owns and controls the media? The only thing worse than Government controlled Media is Media controlled by people who owe their allegiance and Loyalty to people other than WE THE USA PEOPLE.

The first attacks against the Palestine Gentiles begin in 1946 with the bombing of The King David Hotel. The Menachem Begin-led Irgun planned and conducted the massacre of 92 British, Arabs and Jews, wounding 58 others. As head of the Jewish Agency, David Ben-Gurion approved the operation. It was to destroy British-gathered evidence that its leaders colluded with the Haganah, Palmach, Irgun and Stern gangs in a wave of terrorist crimes and killings. This occurred while the Nuremberg Trials were being held in Germany, and guess what, land was taken from the British Mandate of Palestine and given to the terrorists. The terrorists called the land Israel. Whenever the Gentiles tried to reclaim their land, more and more of their land was taken by Israel.

On June 5, 1967, Israel illegally attacked Egypt, Jordan, and Syria. **Israel is still illegally occupying some of this land INCLUDING THE INTERNATIONAL PROPERTY OF JERUSALEM.** On June 8, 1967, Israeli forces attacked the USS Liberty in International waters and killed 34 Americans and wounded 171. Surely the dropping of ignited Napalm (Flamethrower fuel) on the living is a greater Holocaust than the cremation of the dead. This attack on the United States was covered up and labeled as a mistake. Was the mistake; that Israeli jamming of the USS Liberty communications was not complete and it was able to get a message out? Why doesn't PBS have a program about this, which has the United States, Former Soviet Union, and Israeli military tell what they know about this Israeli attack on the United States?

You would think that this would have killed the goose laying the golden eggs for Israel, but today the United States provides over 3 Billion dollars a year in aid, Billions in loan guarantees, Billions for the Military, and protects Israel from prosecution for its crimes. Did the United States surrender to Israel after this 1967 act of War against the United States?

Israel has hundreds of unregulated Nuclear Bombs, but to listen to the politicians and news media, you would think that no-one in the Middle East has any Nukes. The claim is that if Iran is allowed to get Nukes, it will lead all the other Middle East countries to get Nukes. I do not know what Iran is doing, but if two nuclear armed countries (Israel and the United States) were constantly threatening you with sanctions and attacks, what would you do?

Where did Israel get its Uranium and Nuclear triggers from? The United States provided some missiles to Israel for delivery of their Nukes unto the Gentiles; did the United States also provide the Uranium and the triggers? In addition to the Hundreds of unregulated Nuclear Bombs, how much unregulated Polonium and unregulated Anthrax does Israel have?

What was the real final destination of the stray nuclear bombs from North Dakota? Were they to be united with the nuclear trigger or triggers which the US Government claims were mistakenly shipped to Taiwan? PBS needs to have all the involved people tell us what happened. Are there any whistleblowers to help WE THE PEOPLE?

Why does the United States have problems with Iran? Well to start: The democratically elected Iranian Prime Minister Mosaddegh was removed from power in a coup, August 19, 1953 organized and carried out by the United States CIA at the request of the British MI6 which chose Iranian General Fazlollah Zahedi to succeed Mosaddegh. Does the United States really like democracies as it claims? **Was this done for British Petroleum (BP)?** The Iranians ended United States involvement when they rose up against the United States Embassy in 1979. After this Iraq illegally invaded Iran. Where did Iraq get its poison gas from? Saddam was given a tour of a United States poison gas factory; did they provide the poison gas? Why did the United States block an investigation? Iran reached out to

United States by helping us in Afghanistan after 9/11, but instead of using this to start making amends, the United States called Iran part of an Axis of evil.

Iran is not a threat to the United States, so we have no reason to attack it. I believe that the reason Israel claims to be threaten is because Iran thinks that Israel should abide by the same laws as everyone else. Why are the US media and some Politicians talking about illegally attacking Iran? Some even saying it would be better if the United States did it so Israel would not need to do it. Are these people Loyal Citizens of the United States or are they Loyal Citizens of Israel using dual Citizenship to infiltrate the United States media? Why were citizens of Iran given cell phones and access to Twitter and Facebook if not to destabilize and topple the Iranian Government again? Why aren't these being provided to the Palestine Gentiles? Why does the United States claim that the Palestine Gentiles are not to have weapons to defend themselves and must give up their right of return? **Are these the same people that want to take our guns away?**

Some people claim that Israel is a Jewish State. I can claim that I am Jewish and that can be disproved. My Mother was not Jewish and I have never studied Judaism. If this Israel is a Jewish State as some claim, it should have Jewish Values. Is terrorism a Jewish Value? Is denial of the right of return of the Palestine Gentiles (racism) a Jewish Value? Is illegally invading other countries a Jewish Value? Is the illegal occupation of land a Jewish value? Is the illegal building of settlements on illegally occupied land a Jewish Value? Is the destruction of other people's homes a Jewish Value? Is the dropping of Cluster bombs on Women and Children a Jewish Value? Is dropping Napalm on the living a Jewish Value?

Who did 9/11? Was it the United States Government, the Israeli Government (Mossad), or was it some people living in caves in Afghanistan? If it was some people living in caves, they still needed to obtain the intelligence to know that the United States would be conducting Military Exercises and war games that morning. Was it Israeli Mossad and not Arabs aboard the planes that did 9/11? Israel attacked the United States in 1967 and it was covered up. What else is the Government of WE THE PEOPLE hiding from us? Benjamin Netanyahu said that 9/11 will be good for Israel. Why was the health of WE THE PEOPLE put at risk in the rush to cleanup the crime scenes? **Why weren't these investigated before the invasions of Afghanistan and Iraq?** Why were the pro-Israeli supporters in our government so quick to blame it on Iraq and why did others want to blame it on people living in caves in Afghanistan? Was this because of the Trans-Afghanistan pipe line? There was no evidence that any of the hijackers were from Afghanistan, but British and US Forces illegally invaded Afghanistan on October 7, 2001. In December 2001, Hamid Karzai was installed as Chairman of the Afghan Interim Authority. A deal on the Trans-Afghanistan pipeline was signed on December 27, 2002 by the leaders of Turkmenistan, Afghanistan and Pakistan. The United States then decided that it wasn't so important to get Osama Bin Laden after all and Britain and the United States begin the illegal invasion of Iraq on March 20, 2003. **Is this a repeat of the 1953 toppling of the Iranian Government?**

What caused the collapse of World Trade Center (WTC) Building number 7 which was not attacked by any airplanes, but fell in the same manner as buildings number 1 and 2? What Government and Financial records were destroyed? Who made money on the stock market as a result of 9/11? Why hasn't our government released all the 9/11 related Photos and Videos? Is it just a coincidence that President Bush's Brother Marvin was on the board of directors of Stratesec (formerly known as Securacom) from 1993-2000. Securacom received a contract to provide (electronic) security services for the World Trade Center in 1996. The contract ended in 1998 after the installation of a new security system in the WTC buildings. What was installed, who made the equipment, and who inspected it? **Was it demolition explosives and not security equipment?**

Since Israel provides the phone service with back doors to the United States Government, it likely has access to all United States intelligence. Israeli owned companies and holding companies may also have access to your Phone and Phone Banking records through subcontracted billing.

Why doesn't the Supreme Court use its Constitutional Powers and stand up for WE THE PEOPLE and tell Congress and the President that it is unconstitutional to wage war before a formal declaration of war. Why doesn't the Supreme Court take it upon itself and rule that signing statements are an unconstitutional modification of the law? Why must we need to show harm and have lots of money to pay lawyers before the Supreme Court represents us? Is the Supreme Court still intimidated by President Jackson's refusal to abide by their ruling in favor of the Cherokee?

Why are the Jews sometimes blamed for the Wars since the 20th Century? In 1882 the first Zionists begin with Jewish youths calling themselves Hoveve-Zion. This was considered practical Zionism and was used to promote immigration and settlements in Palestine. Political Zionism (Zionism, Zionists) officially began in 1887 with the First Zionist Congress in Basal, Switzerland. The purpose of this organization was to create a worldwide movement with members in every Nation-State to develop a Jewish claim to a Palestine homeland instead of settlements. This was opposed by the Jews that claimed they were a religious denomination and not a National Group, but they were cast aside and some are now living in Iran and the United States. After WWI the Palestine land coveted by the Zionists had been freed from Ottoman rule and was put under control of the British Mandate of Palestine. The secret Balfour Declaration which surfaced at this time was a pledge of British support for a national homeland for the Jews in Palestine. This was the beginning of the Arab-Israel problems which exist today. A Jewish agency was created in Palestine to represent the Jews.

Was this Zionist organization responsible for President Wilson turning a European War into World War I? What was US Supreme Court Justice and Zionist Brandeis involvement in encouraging President Wilson to declare war on Germany? Did Great Britain pass up an equitable peace agreement with Germany before the United States entered the War? In 1913 major changes were made to our Republic. Who were responsible for these changes? The Bankers, the merchants of death, the war mongers, the Zionists, or were they all in cahoots?

In 1913, Congress created the Federal Reserve (FED) and the United States money was turned over to private bankers who remain unknown to Congress and has never been audited. Who were behind this? Justice Brandeis (before his appointment to the Supreme Court) helped create the FED. The FED was supposed to preserve the value of our currency, but it has been a complete failure as 1 dollar then is only worth 4 cents today. In addition to this there have been 2 major depressions. How much income are these private bankers making from the money that Congress borrows and gives away to Foreign Countries in the form of money gifts, military equipment and loan guarantees? It is time to return our money to a United States Public Bank of WE THE PEOPLE. We need a complete and public audit of ALL government spending since 1900.

In 1913, the State Representatives to the United States (US Senators) were taken from the states by the 17th Amendment and made representatives of the people. The reason for this change was charges of corrupt Senators. Who were behind these charges and how wide spread was the corruption? When selected by the States, the Senators were voting against War, but 4 years later (2 election cycles) when two thirds of the Senators were selected by political (special) interests, and voted on by the people, they voted for war. It seems as if today, they are more interested in war than representing WE THE PEOPLE. They also put demands upon the States which WE THE PEOPLE are required to fund. It is time to return the US Senators to being representatives of the States. The Senators will then, no longer need campaign money to get elected. WE THE PEOPLE have our US House of Representatives and if we do not like the US Senators chosen by our State, we can vote our State representatives out of office.

In 1913, the 16th Amendment was added to the US Constitution. This allowed the United States Congress to lay and collect taxes on income from all sources and distribute it however Congress desired. Congress has shown that they are not good stewards of our money. The National Debt was \$12 per person in 1910 before the Income Tax amendment and on Feb 19, 2010 it was estimated to be \$40,294 per person and is estimated to be increasing by more than \$12 per day. Why are we sending our money to the US Government and allowing

Congress to add strings to it and take out overhead in order for WE THE PEOPLE and the States to get our money back. Congress is NOT a good steward of our money and the need to repeal this amendment is obvious. It needs to be replaced with the requirement that the Federal government cannot spend more in one year than collected in the previous year and give the States the power to determine how much of it's Citizens wealth if any will be collected to provide for operation of the Federal Government.

In 1913, the Anti-Defamation League was created in the United States. Its stated purpose is to combat racial and religious prejudice, and discrimination. It does perform these functions, but it also seems to demonize those who speak out against or question the Zionists. Was it really created to provide propoganda for the Zionist cause?

In 1914, the war in Europe was started.

In 1915, The RMS Lusitania was sunk. Who were the lawyers in Washington DC and people behind the lawyers that kept the passengers on the RMS Lusitania from being notified that it would be traveling in a war zone?

In 1917, the United States declares war on Germany and turns a European War into World War I.

In 1919, Peace Treaties made concerning WWI. WHO attended, WHO dominated, WHY?

In 1941, the United States declares war on Japan after being attacked by Japan.

In 1950, the United States officially begins an illegal war in Korea.

In 1964, the United States officially begins an illegal war in Vietnam.

Between 1969 and 1973, the United States illegally bombed and briefly invaded Cambodia.

In 1971, Daniel Ellsberg released the Pentagon Papers, a top-secret Pentagon study of US government decision-making about the Vietnam War to The New York Times and other newspapers. These were about the Vietnam cover up. Why haven't the perpetrators of these War Crimes been prosecuted in an International Court of Law?

In 1991, the United States illegally invades Iraq the first time.

In 2001, the United States illegally invades Afghanistan.

In 2002, whistleblower Sibel Edmonds is not allowed to tell WE THE PEOPLE about everything she knows about treason at the highest level of the United States Government. She has been trying to expose criminal activity and treason at the highest levels of the US Government, Congress, Pentagon and State Department. She has exhausted every conceivable channel in the courts, Congress, and elsewhere. PBS needs to broadcast what this illegal activity is that the United States Government is hiding from WE THE PEOPLE.

In 2003, the United States illegally invades Iraq a second time.

In 2006, the Palestinians voted a landslide victory in national legislative elections to Hamas. This election was monitored and certified by the United Nations, but the United States and Israel apparently had not gotten the election fixed as desired. Although in 2002 President Bush stated: "I call on the Palestinian people to elect new leaders, leaders not compromised by terror.", the United States then labeled Hamas a terrorist organization and placed economic sanctions against the Palestine Gentiles living in Gaza. Doesn't the United States claim that it supports democracy?

In 2008, many candidates for office in the United States paid homage to AIPAC. The following are excerpts from selected speeches and my comments.

Candidate Barack Obama:

"Let me be clear. Israel's security is sacrosanct." **What about the security the Palestine Gentiles which are being persecuted by Israel?**

"We will also use all elements of American power to pressure Iran." **What has Iran done to the United States?**

"I was interested to see Senator McCain propose divestment as a source of leverage." **Why not divestment of Israel, an Apartheid State and in violation of International law?**

"We should also pursue other unilateral sanctions that target Iranian banks and assets." **Why not Israeli banks and assets?**

"Finally, let there be no doubt: I will always keep the threat of military action on the table to defend our security and our ally Israel." **What makes Israel an ally of the United States? It's attack on the USS Liberty?**

"As members of AIPAC, you have helped advance this bipartisan consensus to support and defend our ally Israel."

Candidate Hillary Clinton:

"If the Iranian government wants to become a responsible member of the international community we would wholeheartedly welcome that change." **Why isn't Israel required to become a responsible member of the International community?**

"Now my third principle is standing up against hatred and anti-Semitism wherever it is found and it's not only Israelis and Jews who need to be speaking out against anti-Semitism; it is every fair thinking person who understands that it directly affects you as well." **What about anti-Gentitism?**

Candidate John McCain:

"When President Truman recognized the new State of Israel 60 years ago he acted on the highest ideals and best instincts of our country." **He rewarded terrorists for their uprising against the British Mandate of Palestine. This is no different than Neville Chamberlain expecting peace when he took land from Czechoslovakia and handed it over to the Nazis.**

"I strongly support the increase in military aid to Israel scheduled to begin in October." **Why are we giving aid to Israel which is an Apartheid state and is in violation of International Law?**

"It's [Iran's] flouting of the Nuclear Nonproliferation Treaty would render that agreement obsolete and could induce Turkey, Egypt, Saudi Arabia and others to join a nuclear arms race." **Israel has never signed the Nuclear Nonproliferation Treaty and has unregulated Nuclear weapons.**

"The State of Israel stands as a singular achievement in many ways and not the least is its achievement as the great democracy of the Middle East." **Does a great democracy violate International Laws and say it will not return illegally occupied land?**

Candidate Nancy Pelosi:

"For many reasons, it is important for us to support the security of Israel. It is in the national interest of the United States of America to support the security of Israel."

How? Its criminal activity makes the United States less Secure.

"The bill underscores the U.S. commitment to Israel's security by ensuring that Israel is treated like NATO members, as well as Australia, New Zealand, and Japan, for purposes of expediting exports of essential military equipment. This represented real change. In addition, the bill begins the implementation of the new 10-year memorandum of understanding on U.S. security assistance to Israel and requires that Israel's qualitative military edge be empirically assessed on an ongoing basis. Howard Berman and Gary Ackerman were very instrumental in the -- as well as Ron Klein, from the state of Florida. Ron Klein, Gary Ackerman very important in all of this. The bill recognizes what I already said, that Israel's national security is a priority for the United States and it recognizes the request for increased security assistance for Israel. I don't know if Harry [Reed] or John Boehner told you this earlier, but the first installment of this increase, \$170 million, will be in the supplemental appropriation bill the House will consider soon, in fact, that we are considering now, so we can expedite this." **Why are we committing to the defense of Israel and stock piling hundreds of Millions of dollars of military equipment in Israel?**

"And we share a common cause: a safe and secure Israel, living in peace with her neighbors." **Israel would have peace if it would abide by International Laws like is required of everyone else.**

Candidate Mitch McConnell:

"I sponsored several pieces of major legislation in support of Israel including a Palestinian Anti-Terrorism Act of 2006 which Tim referred to; that Bill as you know restricts aid to the Palestinian Authority unless and until it acknowledges Israel's right to exist, commits itself to prior agreements, institutes financial transparency and begins to dismantle its terrorist infrastructure." **Why isn't Israel required to recognize the Palestinian's right to exist and end its terrorism against the Palestine Gentiles?**

"More recently I co-sponsored a Bill that would impose sanctions on Iran and on any nation that supports its nuclear program and I--and looking ahead, the singular challenge posed by the Iranian regime all by guarantees that future Congresses will have an opportunity to even further strengthen American Israeli ties." **Why not sanctions on Israel for its violations of International laws?**

If WE THE PEOPLE secedes from the Union will we be treated so nicely? If these people want to represent Israel why don't they move to Israel? Are they being blackmailed with unregulated Nuclear Bombs, Polonium, Anthrax, etc. that they are so willing to sacrifice the Blood and Treasure of WE THE PEOPLE for a State that is in violation of International Law? How secure are International flights from Israel? Does Israel have WMDs stored in a building near you? Prime Minister Benjamin Netanyahu says that Israel is not going to end its illegal occupations, so why are we stock piling 100s of Millions of dollars of Military equipment in Israel? **If we are going to help anyone, shouldn't we be coming to the defense of the illegally occupied people?**

Why are Europeans who disagree with the officially mandated truths about World War II put in Prison? Why does our government complain about China restrictions on the Internet, but does not talk about restrictions on European access? Are the Search engines in the United States being restricted by owners not loyal to WE THE PEOPLE?

In 2008, PBS claims they do not have advertisers so they can be open and honest with WE THE PEOPLE. They fail to mention that they have sponsors like AARP which kept Ron Paul, Mike Gravel, and Dennis Kucinich from appearing in the Presidential debates on PBS. Is it just a coincidence that they've voted for WE THE PEOPLE instead of Israel? Is AARP un-American? Do sponsors also keep Israeli brutality against the Palestine Gentiles from being covered in detail? There needs to be a full investigation into why AARP was allowed to set requirements for participation in the Presidential Debates. Why weren't the Independent candidates provided this same forum?

In 2009, Barack Obama is sworn in as President of the United States and selects Rahm Emanuel as his Chief of Staff. Rahm Emanuel demonstrated his lack of loyalty to the United States by serving in the Israeli Military instead of the United States Military. Who has their finger on the United States Nuclear trigger, President Obama or Rahm Emanuel? How many other Israeli Citizens are in high levels of our government? **Who is targeting the United States Nuclear Weapons?**

"My Government, My Government why are you betraying me!"

There are the Radical Christians who are paying to relocate Jews to Israel with the intent that they will be blown to smithereens and then there will be 1000 years of peace. Did it ever occur to them that if such a calamity were to happen and any Humans survived, it would probably be 1000 years before any tribes come into contact with each other and begin civilization(?) anew. What the Candidates need to do:

Make sure all the Candidates are vetted by people Loyal to WE THE USA PEOPLE.

Give Recognition to Senators, Representatives, and Presidents who:

- Are LOYAL to WE THE USA PEOPLE.
- Owe their Allegiance to WE THE USA PEOPLE and not a political party or foreign Entity.
- Require voter marked Paper Ballots which are placed in boxes, counted by hand, and stored securely in case a re-count is needed.
- Restore Habeas Corpus.
- Repeal the Patriot act.
- Repeal the War Powers Act.
- End ALL covert operations.
- Investigate ALL Government agencies for Un-American activity.
- Make ALL Government files Public except for the CIA and the FBI.
- Only allow the CIA to collect intelligence and must disclose all others files.
- Only allow the FBI to collect information needed to prosecute criminals.
- Stop supporting the killing of Gentiles by Israel.
- Have all alleged/accused War Criminals prosecuted in an International Court.
- Create the United States Public Bank of WE THE PEOPLE.
- Repeal the 17th Amendment (return selection of the US Senators to the States).
- Repeal the 16th Amendment (Eliminate the Federal tax on income)
- ADD an Amendment which states: "Only Human Citizens can contribute to or otherwise influence the election of a Candidate for Public Office; furthermore, that Human must be a resident of and living in the Jurisdiction which the Candidate will represent."
- Stop ALL interference in other governments.
- Stop ALL foreign aid (Money and Military Equipment).
- Bring ALL US Military Personnel and Equipment home.
- Close ALL Foreign Military bases.
- End ALL Foreign entanglements.
- Require ALL agency rules and regulations to be approved by Congress.
- Conduct complete and yearly PUBLIC audits of all Federal Government spending.
- Put WE THE USA PEOPLE first and require ALL USA Corporations to do the same.
- Promote the Mike Gravel "National Initiative for Democracy" at (WWW.NI4D.US). The National Initiative for Democracy (NI4D) is a proposal which will permit WE THE USA PEOPLE to make or change laws by initiative at all levels of government, including at the Federal level.
